Recital fee is \$120(incl. tax) which includes per recital/competitive costume. Other studios collect this fee during recital time; however we wanted to give you ample notice of this charge. All costume fee's are non-refundable. If the student drops, forfeits, unable to attend classes or the recital, recital fee and costume deposit(s) are non-refundable. The costume(s) will not be given to the student. If you are registered for a recital/competitive classes you are expected to attend the recital. Recital will be at Michael J. Fox Theatre on Thursday June15th in person or a virtual taping depending on COVID guidelines. Of course unforeseen circumstances do happen; in which case the student is unable to attend in that case a costume will not be given to them and if it has been given, it must be returned to the studio immediately.
